Dear Frank Pasquale:

After attending university in Africa and spending seven years living internationally, I wanted to participate in altering how governments, humanitarians, media and academics establish global opinions and strategies towards peace and development. I believe these institutions are hindered by their inability to recognize that propaganda and ineffective leadership skills are contributing to political unrest, deterioration of women and children rights, and the lack of focus on enduring societal investments. Furthermore, I wanted to participate in altering the disproportional and unjust amount of negativity targeted at America citizens globally in comparison to citizens from other countries.

I thought Washington was the best place to try; however, instead it was the place where I became aware that I was a victim of mind control sciences. It was July 2010 when I started evaluating the symptoms I was experiencing and it led me to the conclusion that it was mind control technologies. Even though there has been nine months of traumatic events the most significant one is the non-stop 24 hours a day conversation into my brain (I listen, have conversations and argue with the tormentors and protector(s)).

Mr. Pasquale at this time I could go into a lengthy discussion about my stability and my reputation for integrity and honesty; however I think it is best to say; I Tami Stainfield have not committed a crime, I have not now or ever been a drug user or alcoholic, I have never been unstable or had any mental health issues, and all my income was earned from legal careers. It should also be noted that I am a heterosexual women with limited sexual occurrences since the tormentors tell me that I am in prostitution.

Thus, I would like to ask you or if you know anyone in the New England area that would be able to assist me in bringing a case to the Supreme Court. The case would focus on the negligence or complicity of laws to protect citizens when any of these mind control sciences, Brain Computer Interface (BCI), Brain-Machine Interfaces (BMI), Electronic Stalking and Mind Control (ESMC) and Voice to Skull (V2K) technologies are used unconstitutionally.

I have limited funds (\$700,000) and recognize the case needs to be presented in a way that focuses on the collective society. Recently there has been a significant amount of articles documenting these technologies, thus I ask - since the science has been proven to exist, isn't it the government's responsibility to protect US citizens if they become a victim of these technologies?

Frank, the consequences of these technologies are serious to our world, nation, corporations, states and individuals. It appears the science has gone unchecked and it's in the private sector with no adequate controls. Recognizing many would argue the benefits of these sciences, my experience has been negative. The ability to listen to private communications and thoughts makes old fashion leaks, hacking, and theft of intellectual property seem antiquated. Furthermore

the ability to control physical coordination and movements (logistics, accidents, allergies, etc.) makes our legacy forms of medical fraud seem restrained.

Frank, I am starting the process of understanding why this technology is in the public without the means to help those who become victims and need the legal profession to assist. There have been a couple cases presented to the United States Supreme Court; however, the cases and stories remain hidden. Most documented victims have been ignored, they have no access to legal council, the medical community diagnosis them with traditional tools and / or define them as mental health cases, and the police do not have the knowledge or experience to investigate.

In conclusion, as I have stated to my tormentors this crime is illegal, immoral, and unethical. If you can assist, refer me, and / or direct me to someone who is a legal expert in constitutional law it would be appreciated. This is unconstitutional.
